## Purchase Agreement

AKC Boston Terrier Puppy. Date of Birth \_\_\_\_\_ Male \_\_\_\_\_ Female \_\_\_\_\_

This AKC Boston Terrier Puppy is being sold for the price of \$\_\_\_\_\_ as "Pet Quality" with Limited Registration. A deposit in the amount of \$500.00 is required to hold the puppy of your choice. Deposits are to be paid in Cash, Check or Wire Transfer (only). Deposits are non-refundable. If the Buyer terminates the purchase of a puppy, verbally or in writing, they forfeit their deposit. The Seller has no obligation to refund or use the said deposit on a future puppy. The outstanding balance shall be paid by the Buyer via Wire Transfer (only). The balance is due on or before the 7th week of the puppy's age. Or by cash on pick-up of the puppy. No money apps are accepted forms as payment.

The expected delivery date is \_\_\_\_\_, or such other date as the parties may mutually agree. Buyer acknowledges and agrees that they will forfeit the deposit and any rights to the Puppy if, Buyer fails to complete the purchase of the puppy for any reason, or Buyer fails to pay the balance of the purchase price 5 business days prior to the puppy's 7 weeks from birth. In either event, Seller shall be free to sell the puppy to another party. A boarding fee of \$20 per day will be charged for each day the puppy is boarded by Seller, past the 9th week of puppies birth date. At any time before the puppy is rendered to the Buyer and paid in full, the Seller maintains the right to terminate this agreement and sale of the Puppy. If this occurs, the Seller agrees to return the deposit amount to the Buyer. The Seller agrees to notify the Buyer should this take place via email or letter.

All puppies come with a (1) one year health guarantee. If a licensed veterinarian exam reveals that the Boston Terrier Puppy has a life threatening genetic defect, the Buyer must return the puppy immediately at their own cost, along with a written statement from the attending licensed veterinarian as to the health problem. In addition, the Buyer must have an additional written report from an unassociated veterinarian stating the same problem. In addition, my personal veterinarian will also examine the Puppy for their opinion. No veterinary bill will be paid by the Breeder.

The guarantee does not include refunds. The Seller will provide a replacement puppy of comparable quality, color, gender and delivered at the Buyers expense. The Seller will not replace a puppy due to heat stroke, hypoglycemia, abuse/neglect, temperament, or improper socialization. Buyer agrees that they have thoroughly researched the Boston Terrier breed and understand the many health issues they can possess. Buyer is responsible for all medical costs of their puppy. This guarantee does not cover accidents or non life threatening genetic defects. The following are not considered "life threatening genetic defects", Cherry Eye, Erect Ears, Ectropion, Allergies, Undescended Testicles, Loose Knees or Hips, Stenotic Nares, Elongated Soft Palate, Umbilical Hernia, Dermatitis, Demodectic Mange, Over/Under Bite, Hypoglycemia, Coccidia, Giardia, Kennel Cough, Fungal Infections, Parasites, Distemper, Parvo, Canine Influenza, and any other communicable diseases.

**\* Caution\*** If you expose your puppy to contagious environments before the puppy is fully vaccinated while their immune systems are not able to fully respond, you are potentially exposing them to any/all communicable diseases.(outdoors, grass, dog parks, other animals, vet offices, social settings, etc.)

The Breeder agrees that the puppy has been found to be in good health, up to date on it's immunizations, dewormed and Florida Health Certified. The Buyer has 48 hours from the date of this agreement to have the puppy examined by a veterinarian of their own choice. If possession occurs on the weekend or a Holiday, the Buyer shall have an additional 24 hours to have the puppy examined. The health guarantee is null and void if the puppy was not evaluated in the original 48 hour period or has not had all up to date required vaccinations. In addition, the puppy will not be covered under the (1) one year health guarantee if not on heartworm prevention or have not been spayed or neutered. Proof of this will be required by a licensed veterinarian.

Returning the Boston Terrier Puppy will be at the Buyer's own expense. If the Buyer chooses to keep the puppy, then no replacement will be given. After one (1) year, the Seller has no warranties, either expressed or implied.

No replacement puppy will be given if the puppy has been euthanized without the permission of the Seller, before a consultation with the treating veterinarian. The exception to euthanasia would be in the case of severe injury or suffering on the part of the animal.

The puppy was bred as a companion animal, and Seller does not provide any warranty as to the puppy's fitness for any specific purpose, including: obedience trials, agility, tricks or competitive sports, emotional support/therapy, show ring performance, and/or breeding purposes. The Buyer agrees that any photos or videos that are sent to the Seller or posted on social media, can be used by the Seller for use on their website or social media accounts.

It is agreed that at no time will the Buyer rehome, sell or give this Boston Terrier to a pet store, a puppy mill operation, a dog pound, a dog broker or any similar enterprise or sell at auction. In the event the Buyer (new owner) needs to rehome this Boston Terrier, the Buyer must contact the Seller to rehome and offer the first right of refusal.

I have read the above and with full understanding of the contents herein, I willingly enter into this agreement.
